### Key Leader Engagement Part III: USARPAC

On May 8, 2023 the Honorable Governor Lemanu P. S. Mauga met with U.S. Army Pacific

Commanding General Charles A. Flynn to discuss American Samoa's future plans on establishing itself as a hub for the U.S. in the Pacific region.

The rising power and influence of the Pacific region prompted the Honorable Governor Lemanu to take preliminary steps to Samoa's build up American defense economically and strategically. As the U.S. Territories are the doorstep in the United States it is only imperative that American Samoa initiate a strong partnership with key leaderships promoting regional security presence and deter potential adversaries. Additionally, the discussion overarches the opportunity to strengthen relationships between the United States and the Pacific Region maximizing future through opportunities.

Three important topics were discussed during the meeting:

• General Commander's decision to deploy a civil affairs team to conduct an assessment in American Samoa, with the aim of assisting in the development of better strategic planning capabilities.

- Furthermore, the discussion also encompassed the issue of Space A military travel options that were suspended amidst the pandemic. Facilitating the commencement of Space A, specifically the C17 and C130 flights, has the potential to provide travel options for both military personnel and veterans,
- The potential presence of the National Guard to provide support as needed. An upcoming meeting among Commanders is scheduled this week wherein General Flynn will address the issue National Guard leadership.

The Honorable Governor Lemanu P. S. Mauga presented a Samoan gift to both the General

Commander and spouse. The same gesture was afforded to the Honorable Governor and First Lady Ella Mauga. MAJ Jerrod T. Avegalio, a Leone native from the Avegalio family, assisted the Honorable Governor and A.S. delegation to meet with the Command General. Avegalio has expressed his passion in Aviation and seeks to serve as an instrument for empowering aspiring soldiers from American Samoa in their pursuit of military excellence.









### Day 1 American Samoa at the Territorial Climate & Infrastructure Workshop

The U.S. Department of Interior Office of Insular Areas convened the Climate Infrastructure Territorial Workshop 2.0 for the second year since the announcement of the Bipartisan Infrastructure Law signed by President Biden on November 15, 2021 and the Inflation Reduction Act last year. The objective is to provide assistance to all territories in order to maximize their opportunities to successfully apply for and receive these federal funds for priority climate and infrastructure projects. To achieve this, federal agencies and significant subject matter related organizations have been invited to share about available resources to include new funding opportunities and technical assistance. The seven specific focus areas are

- 1. Built Infrastructure
- 2. Nature Based Solutions
- 3. Energy
- 4. Broadband
- 5. Water
- 6. Invasive Species
- 7. Cleanup Revitalizing & Recycle.

The American Samoa BIL/IRA team led by AS BIL/IRA Coordinator, **ODAPM** Director Lisa **Tuatoo** includes Directors and staff of departments and offices with mandated functions related with priority projects submitted and prepared under BIL/IRA funds.

The Executive Director Wallon Young ASPA, CEO Chuck Leota ASTCA. Directors Falenaoti

Fruean DPA, Faleosina Voigt DPW, Petti Matila ASDOC, Faamao Asalele Misipati Salanoa Amaama Tofaeono GRO, and Tavita Togia BIODIVERSITY.

The Honorable Lemanu P.S. Mauga, Governor of American Samoa met with the AS BIL/IRA team on Sunday, May 7, 2023 in Honolulu, Hawaii before his departure for reminded the directors and staff about the importance of this TCIW 2.0 workshop and for the team to successfully submit applications to request funds for critical priority climate and infrastructure projects for the territory. The Governor Lemanu encouraged the team to network, learn from technical assistance offered and foster relationships with federal counterparts to ensure that the territory will benefit from these once in a generation funding opportunities to address climate change, improve infrastructure and save lives of the people of American Samoa.

In her presentation during the opening ceremony, Director Lisa Tuatoo shared on behalf of the territory, the priority projects, challenges gaps and experienced when preparing applications under BIL/IRA funding opportunities. Although local cost matching has been waived by the DOI grant funding opportunities for the territories, a request was made for all other federal agencies to follow suit in this initiative.

Other challenges include the National Environmental Policy Act (NEPA), Build America Buy American Act (BABAA), Supply chain issues, DOI annual allocation, Period Performance (POP), Equity in competitive grants and training and capacity building to name a few. In accordance to the TCIW 2.0 agenda, the first presentation from American Samoa is under the Infrastructure. This was presented by DPW Director Faleosina Voigt on behalf of herself and DPA Director Falenaoti Loi-On Fruean on the priority Built Infrastructure projects list. Other territories gave similar presentations after Director Faleosina Voigt. These were followed by two Infrastructure breakout sessions about resiliency and opportunities transportation infrastructure compliance, regulatory, construction and sustainability considerations. When asked about one outcome from this TCIW 2.0, Director Lisa Tuatoo responded, "to approve all of American Samoa's BIL/IRA grant

### Day 2 American Samoa at the Territorial Climate & Infrastructure Workshop

In a full fledge agenda on the second of the Territorial Climate day Infrastructure Workshop 2.0, the presentations from American Samoa began with the Invasive Species focus area and is presented by Deputy Director Mrs. Selaina Tuimavave of the Department of Marine and Wildlife Resources and Mr. Tavita Togia of the Biodiversity office of the Governor's office. The Nature Based solutions presentation is delivered by Director Petti Matila Department of Commerce and Mr. Tavita Togia of the Biodiversity office.

The Cleanup Revitalizing and Recycle presentation is by Director Faamao Asalele of the American Samoa Environmental Protection Agency. In all of their presentations. American Samoa directors identified priority climate and infrastructure related projects, associated challenges and desired outcomes of their proposals. The territories of Guam, Commonwealth of Northern Marianas (Saipan) and US Virgin Islands also shared their projects.

addition to the Territory's presentations, the keynote address for today is by the US Department of the Interior Ecosystem Restoration Program. This is followed by the federal round tables sub-sessions for the American Samoa Pollution with **US Environmental Protection** Agency and with the American

Samoa Nature Based solutions with Federal Emergency Management of Agency, Department Interior (USFWS, USGS. BOR). US Department of Agriculture (NRCS, USFS), US Department Of National Transportation, Oceanic Atmospheric Administration, US Army Corp of Engineer and USEPA. An opportunity was also afforded to American Samoa to meet with the National Renewable Laboratory, a national laboratory of the US Department of Energy, Office of Energy Efficiency and Renewable Energy, operated by the Alliance for Sustainable Energy, LLC. The NREL is providing assistance with updating of the American Samoa State Energy Security Plan and is working closely with the American Samoa Renewable Energy Committee. The American Samoa Power Authority Executive Director Wallon Young raised the critical and urgent issue of the LBJ Tropical Medical Center large standby generator from 1968 where the parts needed are no longer manufactured and we had to buy them from foreign countries. He also states that although we are discussing renewable energy, for redundancy and back-up purposes, we are still retaining diesel for electricity needs.

The General Services Administration session by Ms. Brandy Untalan, the Customer Services Director for Guam, CNMI, American Samoa, Australia and Pacific Islands shared about the types of assistance they provide to all government customers and vendor support. She also encouraged territories to request seminars and training on a variety of GSA topics and resolutions. The GSA training sessions include GSA e-Tools Suite (Advantage, E-Library, E-Buy), GSA Autochoice, GSA vendor and customer self service (VCSS) Invoicing/Payment and State and local programs. Under the BIL, Ms. Untalan shares about the GSA MAS program with electric vehicle charging stations and electric vehicles. and under the GSA Autochoice, were the alternative fuel vehicles such as medium and heavy duty trucks, buses, ambulances, wheelchair vehicles and wreckers and carriers. She also provided information on the 1122 Program and identified Ms. Sapi Ma'o Ena, American Samoa Office of Procurement Deputy Director as the

Government Chief of Staff Loa Tuimavave Tauapai Laupola, Department of **Public** Works Director Faleosina Voigt, DPW Senior Engineer Estella Rubin, ODAPM Director Lisa Tuatoo, AS State Hazard Mitigation Officer Sandi Tonumaipea and the ODAPM Hazard Mitigation team Camilla Poufa and Max Haleck III with FEMA representative Michael Kern discussed alternative routes of the previously approved plans to ensure eligibility under separate federal funding available for this project. A week earlier, the Fagaima drainage project meeting held at the ODAPM office in Tafuna was attended by Honorable Senator High Chief Magalei Logovii, Honorable Representatives Larry Sanitoa and Sam Meleisea with DPW and ODAPM teams to provide an update of this long overdue project that will greatly benefit residents of the Tualauta district and the people of American Samoa utilizing these public roads.









## Day 3 American Samoa at the Territorial Climate & Infrastructure Workshop



In continuing the momentum of a resourceful packed schedule on day three (3), the Territorial Climate Infrastructure 2.0 begins with the Energy Infrastructure Reinvestment (EIR) program describing Inflation Reduction Act of 2022 appropriations and eligibility under Energy Infrastructure Reinvestment 1706 EIR. The US Department of Energy Loan Program Office confirms their commitment whereby the LPO "engages early with applicants and remains a partner throughout the lifetime of the loan." A special note states that IRA appropriates \$5 billion through September 30, 2026 to carry out EIR with a total cap on loans of up to \$250 billion. Next were federal presentations on Energy and Invasive Species then followed by roundtable discussions for the Commonwealth of Northern Mariana Islands on Energy and the US Virgin Islands on Invasive Species with federal counterparts. The federal roundtable continued

with National Renewable Energy US Laboratory, Environmental Protection Agency, US Department of US Department Energy, Transportation, US Department of and US **Economic** Agriculture, Development Administration.

The Environmental Justice Technical Assistance is presented by the US EPA Region 9 Laura Ebbert, Director of Tribal, Intergovernmental and Policy Division and CJ Mishima. Environmental Justice Coordinator. They described environmental justice as a "phrase we use to describe the principles of fair treatment involvement meaningful all persons." The EJ grant programs shared are:

- 1. Thriving Communities Technical **Assistance Centers**
- 2. Environmental Justice Thriving Communities grants Environmental and Climate justice grant programs.

Some eligible grants activities include building refurbishment that reduce greenhouse gas emissions and other pollutants, development of disaster preparedness plans, community revitalization planning in support of climate resiliency and adaptation to name a few.

The American Samoa Government Chief of Staff High Chief Loa Tuimavave Tauapai Laupola and Team ASG **BIL/IRA** lead/Coordinator, ODAPM Director Lisa Tuatoo were invited by the Honorable Ms. Brenda Mallory, the Chairman of the White House Council on Environmental Quality to a meet and greet. This meeting is with each territory's governor's have representatives to opportunity to listen and learn directly on issues of importance to them. The Chairman would like to learn about the US Territories climate change, conservation environmental justice agenda and how the federal government can be a partner.

The consensus from the territories were shared challenges with the National Environmental Policy Act, Build America Buy America Act, Supply chain shortage, Equity in competitive grant applications to include attention to the measuring tools such as Benefit Cost Analysis, Threat and Hazard Identification of Risk Assessment, etc. and to have a more uniformed holistic approach. For American Samoa, the issue of the lack of a Federal Aviation Administration tower at the Pago Pago International airport was raised. The COS HC Loa has pleaded with the Honorable Chairman to hear and understand our priority needs especially with critical climate and infrastructure priority projects expressed by Honorable Lemanu Mauga, Governor of American Samoa.

Mr. Tavita Togia presented on behalf of American Samoa during the Invasive Species federal roundtable sub-session with US DOI (Fish & Wildlife Service, US Geological Survey, National Park Service, Office of Insular Affairs), US Department Agriculture (US Forest Service, Health and Plant Animal Inspection Service. Natural Resources Conservation Service, Agricultural Research Service) National Oceanic and Atmospheric Administration, Hawaii and US Indo-Pacific Command with ASG and directors staff in attendance. He shared about specific invasive species in the ongoing territory and and completed eradication work thus far.

The federal agencies representatives sang his praises, even highly commended Mr. Tavita Togia on his work and encouraged him and his team to continue doing great things.

The breakout sessions that follow are the Electric Vehicles, Energy Storage, Generation and Renewables and Advancing a National Early Detection and Rapid Response Framework for Invasive Species: Benefits of the Framework and Collaboration Opportunities with Territories. The concurrent sub-sessions afterwards were:

- 1. National Renewable Energy Laboratory All Territory Roundtable Discussion Territorial Energy and Security Plans
- 2. Protecting Island Communities through Biosecurity
- 3. Hazard Mitigation Planning (Federal Emergency Management Agency).

During the Hazard Mitigation Planning session, American Samoa has been recognized by FEMA as having a completed and updated Territorial Hazard Mitigation Plan until 2025. American Samoa has a strong hazard mitigation program. The American Samoa State Hazard Mitigation Officer Sandi Tonumaipea shared about the territory's Hazard Mitigation Council chaired by Honorable Talauega E.V. Ale, Lieutenant Governor and Governor's Authorized Representative who has been actively involved with the HM council and his visible proven leadership contributes to moving hazard mitigation projects forward.

The American Samoa team consisting of the COS HC Loa, DOC Director Petti Matila, ASTCA CEO Chuck Leota, ODAPM Director Lisa Tuatoo. Dr. Ginger Porter, Mr. Ted Leiato, Mrs. Edna Asalele Noga, Mr. Joseph Meredith met with the US Department of Commerce National Telecommunication and Information Administration representatives Mr. Tim Stelzig, Regional Director (Alaska, Territories IFA), Mr. Cort Buffington, Technical Assistance Advisor IFA), Mr. Ethan Lake and two others who provided important information about the Broadband Equity Access and Deployment program. The Internet for All (IFA) "ensures that everyone in America has access to affordable, reliable, highspeed internet." A good amount of was spent discussing time "affordability" part of the IFA goal for American Samoa. The DOC Director Petti Matila inquired with the federal partners on the projected timeline of application, award, project installation and completion period relevant to the BEAD funding guidelines. The CEO Chuck Leota asked about the federal review status of the ASTCA's Middle Mile application under BIL and was advised by Mr. Seilzig that he will reach out to the Middle Mile team and inform the CEO. In his efforts to advocate for American Samoa, COS HC Loa requested with the NTIA team to help our territory achieve the goals of President Biden's Bipartisan Infrastructure Law of the internet for all.



## Day 4 American Samoa at the Territorial Climate & Infrastructure Workshop

The Territorial Climate Infrastructure Workshop 2.0 day four (4) began with welcoming congratulatory news for American Samoa announcement by Honorable Carmen Cantor for the approval of the Inflation Reduction Act technical assistance program in the amount of \$2.8 million to the American Samoa Office of Disaster and Petroleum Assistance Management (ODAPM) for efforts to "collect and update data on sea level rise to ensure information is most current and accurate for all seven islands." The Assistant Secretary Cantor continued to announce the US Department of Interior grant awards Guam. Commonwealth Northern Marianas and the US Virgin Islands. The TCIW 2.0 participants also had an opportunity to hear from the Honorable Brenda Mallory, Chairman of the White House Council on Environmental Quality. This was followed by the White House Ocean Climate Action Plan briefing. The American Samoa Government Chief of Staff Loa Tuimavave Tauapai Laupola spoke on behalf of American Samoa and the territories in a plea to federal leadership in attendance to identify ways to remain in compliance with regulations, while streamlining federal government processes expedite the implementation critical and life-saving infrastructure projects. The Chief's remarks was met with a standing ovation and cheers and applause from the territories.

The morning sessions included federal government agencies presentations on Broadband and Water. The Broadband presentation discussed the Federal **Communications Commission** 

National Broadband Map Fabric updates, next steps, affordable connectivity program and the ACP outreach grant program components. Other important topics include the FCC rulemaking to prevent digital discrimination and resources available for National Broadband Map,

Affordable Connectivity programs to include Outreach site for related materials. The US Department of Agriculture presented on the USDA and overview of Rural utilities service program. The types of funding for broadband telecommunications infrastructure loan, rural broadband, community connect ReConnect grant and programs, and the Broadband technical assistant grant. FEMA also discussed the Interagency Recover Coordination Broadband and Digital as a Covid 19 Recovery project. As mentioned in the Hawaii Recovery Operations Plan November 2020, "Long term community recovery is the process of establishing a community based, post disaster vision and identifying projects and project funding strategies best suited to



achieve that vision.."

The federal Water roundtable for American Samoa with the US Environmental Protection Agency, US DOI Bureau of Reclamation, US Geological Survey, US Department of Agriculture RD and the National Resources Conservation Service. The American Samoa Power Authority Executive Director Wallon Young presented the Water Infrastructure upgrade, project statuses of the water line replacement, reservoir upgrade to name a few. He also shared about the challenges encountered with shortage of engineers and skilled workers and expounded on the priority projects and needs. The AS EPA

Director Faamao Asalele's invaluable contribution to the roundtable session further strengthened American Samoa's position on the importance of Water infrastructure projects articulated by the ASPA EO Wallon Young.

The American Samoa delegation truly showcased in all TCIW 2.0's seven focus areas. The American Samoa **Telecommunications** Authority Chief Executive Officer Mr. Chuck Leota, Mrs. Edna Asalele Noga and Mr. Ted Leiato well represented the ASG with their Broadband presented at the American Samoa Broadband roundtable with National Telecommunications and Information Administration, FCC, USDA RD, Economic Development Administration and FEMA. One of the priority projects include undersea fiber cable to the neighboring islands.

Mrs. Edna Noga presented on behalf of ASTCA and expounded on the broadband wireless infrastructure, cable landing station and technical operations center, the BLAST network upgrade and of course Cybersecurity. American Samoa needs to harden its infrastructure to Internet for All under the Bipartisan funds Infrastructure Law and protection of its communication assets critical in emergency coordination of emergency response efforts in the untimely events of disasters. Again, a focus on life saving measures for the people of American Samoa.

The sessions that follow include Broadband IFA, Reclamation program and Scenario planning and the US EPA BIL drinking water, wastewater infrastructure. American Samoa maximized these opportunities with full attendance from departments and offices with related functions. The COS HC Loa Tuimvave Tauapai Laupola ensured the ASG's needs are addressed and challenges, gaps are bridged in order to receive these generational federal opportunities are maximized for our Territory.









### Day 5 American Samoa at the Territorial Climate & Infrastructure Workshop



Friday, May 12th, 2023 was the last of the Territorial Climate Infrastructure Workshop 2.0 and is still well attended by the American Samoa delegation especially since the morning session is focused on Office Hours. These office hours are one-onone opportunities between territories and their federal counterparts in the seven focus areas of this workshop; Water, Broadband, Cleanup, Revitalization, and Recycling, Energy, Nature based solutions and Invasive Species and Built Infrastructure. The territories utilize these office hours to discuss in detail grants related issues to include federal regulations and solutions to help push priority projects forward. The US Department of Interior Secretary Honorable Debra Haaland heard the territories' unified request during the TCIW 1.0 last year to allow more time for office hours and this is the reason for these interactive sessions addressing the territories' needs and challenges with their application

development and submissions under the Bipartisan Infrastructure Law and Inflation Reduction Act funding opportunities.

The last and critically important session for the TCIW 2.0 is the National Environmental Policy Act presentation by the US Army Corp of Engineers. The presentation was done Ms. Marian Dean. the by Environmental Planner for the USACE. All territories attended and asked environmentally questions about the NEPA process and compliance issues. The presentation included photos of the Faleasao solar panel area, the High Court of American Samoa and the Jean P. Hayden museum slides discusses whether the sites are listed on the National Register of Historic Places, and if operations and maintenance is approved by the Territorial Historic Preservation Office, and if there will be changes in structural capacity, appearance, site or area, change in

property boundary, archaeological site change in land use and if there will be an increase of traffic in the area that will affect the new proposed historical landmark project.

In her closing remarks, Ms. Gretchen Sierra Zorita shares her awareness of the pacific territories in these two TCIW and would like to strengthen these relations in a country that is focused on east coast region." She thanked everyone for "such amazing discussions sharing and building." The relationship Honorable US Department of Interior Assistant Secretary for Insular and International Affairs, Carmen, G. Cantor thanked the dedicated DOI team lead Mr. Basil Ottley, Vanitha Sivarajan, Julianna Rice, Mathew Dutko, Lydia Faleafine Nomura, Marina Tinitali and the rest of the hard working staff for effective coordination in getting the federal partners and territories together for the workshop.

She thanked the OIA team that "has come together to organize and host a successful workshop 2.0, they have worked for several months and from all I have heard from federal partners and territorial stakeholders, the team has over delivered on their promise to make this week an invaluable experience to all who attended."

Ms. Cantor joins Gretchen in her

The office of insular affairs has a broad mandate for advancing the territory's priorities throughout the federal system and we depend on our federal partners to provide and share their expertise they have delivered. Thank you to all the federal partners that have attended in person and virtually and thank you to White House office of intergovernmental affairs of introductory Rodriguez and associate director Gretchen Sierra Zorita for your continued support and collaboration, we cannot do this successfully without you two."

She continued, "to our brothers and sisters from American Samoa, the Commonwealth of the Northern Mariana islands Guam and the US region islands, I wish all of you safe travels home. Please thank your respective governors for allowing you to spend a week away from your normal duties and responsibilities and for having faith in our promise that this workshop will be a worthwhile investment. You have spent your time at the workshop gaining important insights investing in new relationships and identifying new opportunities.

We have also listened to your challenges and we understand your frustrations. IA is committed to working with you and our federal partners to find ways to push through the obstacles and barriers so that you can have the opportunity to build infrastructure you need to develop and sustain prosperous and safe communities."

Mr. Basil Ottley then thanked and acknowledged all the BIL/IRA Coordinators from each territory and asked the ASG Chief of Staff Loa Tuimavave Tauapai Laupola to end the TCIW 2.0 with farewell remarks from American Samoa delegation with singing of the "Ua Faafetai" song and a short taualuga dance to end the five-day event on a higher note. American Samoa opened

the workshop with a warrior dance and it's only proper to end it the Faa Samoa way. Viia le Atua. O le faamoemoe ua taunuu, o le laau o le soifua lea.
