**GENERAL MEMORANDUM NO. 091 – 25**

The following individuals are named to serve on the Board of Directors of the American Samoa Telecommunications Authority.

These appointments are effective immediately as of the date of this General Memorandum.

Board members shall serve a two-year term, or until replaced by the Governor of American Samoa.

The Chairperson shall be chosen by the Governor while the Board Secretary shall be elected by the Board majority at a meeting that includes a Board quorum consisting of a majority of the named members.

Mr. Haleck is President/CEO of Haleck Enterprises, Inc. a diversified local company that has been in business in the Territory for decades with extensive business operations in American Samoa and Samoa.


