The HCBS Commission will be part of the Office of the Governor to advise on the development, implementation, and coordination of the HCBS programs and policies in American Samoa. It is essential to recognize and acknowledge that establishing the HCBS in conjunction with Money Follows the Person (MFP) actually reflects our *Fa'aSamoa* - especially in how we care for our elders and loved ones living with disabilities in our homes and communities. For years, families and caregivers have carried these responsibilities alone. The HCBS Commission will lay the foundation for a Territory-wide system that will, for the first time, enable financial support for the families and caregivers in the home and community.

HCBS appointees shall serve staggered terms not to exceed two (2) years, except for appointees representing consumers, lived experience, and family members whose terms will not exceed three years. Initial appointments shall be made with staggered end dates to ensure continuity of the Commission’s work. Members may be reappointed for additional terms at the discretion of the Governor.

These appointments are effective immediately. My Boards & Commissions Coordinator, Andra Samoa will facilitate the inaugural meeting as soon as practicable. A separate General Memorandum will be issued with regards to the appointment of the Commissioner who will lead the HCBS.

Please extend to the HCBS Commission members your full support and cooperation as this is the first step in building a modern, person-centered system of care that aligns with federal standards and strengthens support for our families and caregivers.
